WORKSHEET INSTRUCTIONS

A charitable gift of establishing a VeteranShield Sponsorship Fund provides an opportunity for tax savings while generously supporting the growth of **The VeteranShield Project**. In addition, your gift will be directly honoring our Veterans and their families; more importantly, **you will know exactly who your generosity has helped**. This worksheet is totally non-binding, and is provided only as an aid to assist both you and the VeteranShield organization in creating the initial design of your unique Specific Sponsorship Fund. Please remember that you will be able to modify the specifications of your Sponsorship at any time in the future.

Name of Sponsorship

This can be almost any title you wish. Several examples are provided on the VeteranShield.org website. Other examples: “Ms. Jones Third Grade Class of 2009 Sponsorship Fund”; “Excelsior Technology – Employee Sponsorship Fund”; “Purple Heart Recipient John A. Jones Memorial Sponsorship Fund”; Elks Lodge #5013, Any Town, KS, Hometown Heroes Sponsorship Fund”.

Sponsorship Funding

1. Please state your **total contribution amount**, noting the individual and corporate minimums. Please limit non-renewable (one-time) contributions to a maximum of \$100,000.00; renewable (Perpetual Fund) sponsorships are unlimited (see instruction 3, below). **Full recognition of all non-anonymous donors**, listed in order of total contributions actually received (not pledged) to date, will be continuously updated on the VeteranShield.org website and in all our media materials.
2. You must choose whether to send in your full donation now, or to provide a minimum of 25% of your full pledge. If you choose to fund your Sponsorship incrementally, please specify the exact increment amount you are enclosing at this time.
3. Please state if you are planning to renew this Sponsorship after your initial pledge has been awarded (**Perpetual Fund**) or if this is now planned as only a non-renewable donation (**one-time contribution**).

Type of Sponsorship

4. You must specify your intent to fund a **Full Sponsorship** (100% of the total cost of a single VeteranShield – currently \$500 – will be provided by your Fund to honor an eligible Veteran), or a **Partial Sponsorship**, where you will fund only a portion of the total cost, with the Veteran required to provide the balance. If choosing the Partial Sponsorship option, please specify the exact percentage cost of each VeteranShield which you wish to cover (ex: 25% = \$125 at current production costs).
5. We need to know if you only wish to provide Sponsorship only to those Veterans (or their family members) who will state that they have a financial need, and if you will require independent proof of such circumstances. Note: If you wish to provide Sponsorship based on financial need but do not require proof, please so state.

Specific Sponsorship Eligibility

Items 6 through 14: We’ve included these categories and questions to help you be as specific as possible in creating your own unique VeteranShield Sponsorship Fund. Please provide us with as much detail as possible regarding your ideal qualifications for sponsorship, so that we can work with you to design a Specific Sponsorship that will meet all of your requirements. Feel free to use additional sheets, if necessary.

Please Note: The VeteranShield Project will not promote, nor accept funding for, any VeteranShield Sponsorships that would discriminate against or differentiate Veterans on the basis of race, creed, religion, sex, national origin, or any other illegal designation.
